Dr. Gloria B. Pipkin had the distinction of being the second female president of the South Carolina Dental Association, serving in 2015.

Dr. Gloria Pipkin was born in Charleston, South Carolina in 1943 to Issac A. and Kathleen Josey Brunson. She grew up in the Jamestown community near Monck's Corner, South Carolina. Dr. Pipkin graduated from Macedonia High School there in 1961. After high school, she worked for over 10 years in a family medical practice in Moncks Corner. In 1974 she graduated from the College of Health Professionals at the Medical University of South Carolina as a Physician's Assistant. Dr. Pipkin continued with this profession for 11 more years, until entering the College of Charleston, where she obtained a B.S. degree in Biology in 1988. Her dental education was pursued at the College of Dental Medicine at the Medical University of South Carolina, where she graduated in 1994.

Dr. Pipkin began her practice in general dentistry in Monck's Corner following her dental school graduation in 1994. She has served on numerous committees during her career. In 2003-2004 Dr. Pipkin was president of the Coastal District Dental Society. She has served as a delegate to the South Carolina Dental Association's House of Delegates since 1996. Dr. Pipkin had the distinction of serving as the president of the entire South Carolina Dental Association in 2015. Her theme that year was "Branching into the New Age of Dentistry." The Annual Session that year was held at the Charleston Marriott. Among the issues confronting the South Carolina Dental Association that year were: drafting legislation that year to establish clear guidelines for sedation in dentistry, having to contend with several anti-fluoride groups trying to remove water fluoridation programs, dealing with the mid-level provider movement, and addressing the low reimbursement rates for the Medicaid dental program.

Dr. Pipkin is a member of several additional dental organizations: the Academy of General Dentistry, the American Academy of Practice Administration, and the American Academy of Female Dentists. Because of her many contributions to dentistry, she has been selected for Fellowship in the American College of Dentists.

In the community, Dr. Pipkin has been very involved. She is a past president of the Monck's Corner Rotary Club, as well as a Paul Harris Fellow there. Dr. Pipkin has served on the Callen-Lacey Advisory Board, the Berkeley County Museum Board of Directors, the Trident Medical Center Advisory Board, the Palmetto Alzheimer's Advisory Board, the Trident Library Board, and on the Board of Directors of the Goodwill Industries of Lower South Carolina. She was a member of the National Association of Female Executives. Additionally she has also been a corporate sponsor of the Berkeley County Schools. Dr. Pipkin has served as the president of the Hell Hole Swamp Festival, as well as the Concerned Citizens of Jamestown community organization. Dr. Pipkin has been honored as the Honorary Commander of the 16th Airlift Squadron at the Charleston Air Force Base.

Dr. Pipkin was very active at the Jamestown Baptist Church, where she has served as a Sunday School teacher, Music Director, choir member, and the church pianist and organist. For relaxation, Dr. Pipkin enjoyed her hobbies of gardening, needlework, and painting with both watercolors and oils. Due to her artistic talents, she was a loyal member of the Berkeley Artists Guild.

Dr. Pipkin was married to Glenn Pipkin, and they had a son, Glenn Pipkin, Jr.

CORONAVIRUS UPDATE

PATIENT RECORDS

On another topic, providing patients records to another dental practitioner is required by South Carolina law. Board Regulation 39-11, Ethics (1-B) States:

"Upon request of a patient or another dental practitioner, dentists shall provide any information that will be beneficial for the future treatment of that patient."

Further, in accordance with Board policy, dental records are the property of the dentist who performs the dental service; however, a patient who requests his/her records shall have access to such records. Copies of patient records and/or x-rays, or summaries thereof, must be made available to the patient and/or new dentist upon submission of a written release authorization, in a reasonable manner and upon reasonable costs associated with providing such record. This obligation exists whether or not the patient's account is paid in full.

When dealing with patient records is it imperative that you have the required permissions to release any or all of a patient's dental record before duplicating and transferring records. This is critical to ensuring the confidentiality of the Protected Health Information that the document contains.

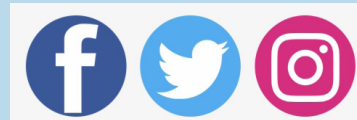
Situations under which you might be asked to provide copies of the patient record include:

- Referring a patient for treatment by another healthcare provider
- The patient has requested the information
- Being mandated by the state dental board or a court of law
- Aiding in a forensic identification
- Dental insurance audit

According to the Health Insurance Portability and Accountability Act of 1996 (HIPAA), permission to release the information can be obtained by having the patient sign an authorization form and adhering to the "minimum necessary standard."

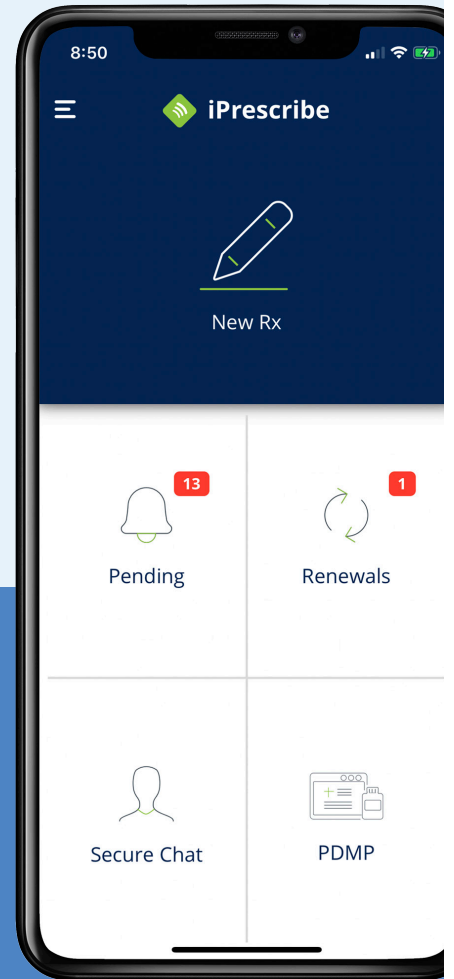

For over 31 years, Our Lady of Mercy Community Outreach (OLMCOS) has believed in community first by assisting neighbors in need living in the Sea Islands and downtown Charleston, helping them achieve their desired path to self-sufficiency. We work to address the root causes of poverty and create systemic change by providing basic and emergency resources, education and specific health programs, as well as coordinated services in the broader community.



The lack of access to regular dental care is prevalent throughout South Carolina, and is especially present for those who live in rural and urban communities who largely are uninsured or underinsured communities of color and low-income levels. OLMCOS' Wellness Center on the Johns Island campus is the only state of the art facility that provides free, comprehensive dental care within a 15-mile radius. Our dental care consists of debridement, deep scaling, prophylaxis, fluoride treatment, restorative dental care, CEREC crown technology, endodontic treatment and oral surgical care. Along with comprehensive care, patients receive health education for oral hygiene, disease prevention and management. We also host an emergency clinic to allow patients outside of our normal service areas to have access to emergency dental procedures.

Through mutually beneficial partnerships with the MUSC School of Dentistry and Trident Dental School, we bring high quality oral health providers to our underserved community and providers to expand our capacity and types of services while providing supervised training and real-life experiences.

In 2019, Our Dental Clinic completed 13,025 procedures totaling a value of more than 1.5 million dollars.

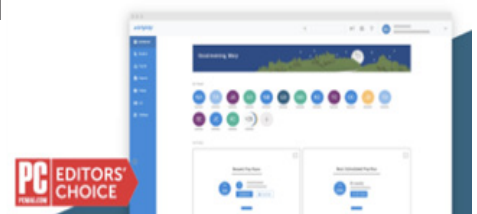

Dr. John Wilmont Parler, Jr 1931-2020, SCDA President 1976-1977

Dr. John W. Parler, Jr. excelled in his many roles of leadership guiding the profession of dentistry.

Dr. John Parler, Jr. was born in Batesburg, South Carolina in 1931 to John Wilmont Parler, Sr. and Mary Law Workman Parler. He attended the Batesburg-Leesville schools growing up and finished high school there in 1949. After graduating from Presbyterian College in 1952, he entered the University of Louisville Dental School where he completed his dental degree in 1956. This was followed by two years in the United States Navy Dental Corps, where he did advanced studies in Oral Surgery.

Dr. Parler practiced general dentistry in Batesburg, South Carolina from 1958 to 1998. He served as president of the Central District Dental Society in 1967 to 1968.

Dr. Parler was a charter member of the South Carolina Chapter of the American Society of Dentistry for Children, as well as being its second president. Additionally he was a charter member of the South Carolina Academy of Practice Administration where he served as their Secretary-Treasurer. Enhancing his continuing education in dentistry, Dr. Parler was a charter member of the Midlands Study Club. For many years he was a member of the Academy of General Dentistry. From 1970 to 1975 Dr. Parler was a member of the South Carolina State Board of Dentistry and served as its president in 1973. Additionally Dr. Parler was a member of the American Board of Dental Examiners and the Association of Southern Dental Deans and Examiners.

From 1976 to 1977 Dr. John Parler served as president of the entire South Carolina Dental Association. While president of the SCDA, Dr. Parler spearheaded the re-writing of the South Carolina State Dental Practice Act. For his presidential reception at the Annual Session that year, he arranged for that event to be held at the Governor's Mansion during the governorship of Dr. James B. Edwards, who was a member of the South Carolina Dental Association. For many years he was a delegate for our state association to the House of Delegates of the American Dental Association.

For his many years of leadership in the profession of dentistry, Dr. Parler was inducted as a Fellow in the American College of Dentists and the Federation Dentaire Internationale.

Dr. Parler was a charter member of the Carolina-Honduras Foundation, where he served as Treasurer. For over 25 years he made one or two mission trips each year helping serve the dental needs of the underprivileged in the Honduras.

Civic activities for Dr. John Parler include being a member of the Civitan Club as well as being the Chairman of the American Red Cross Bloodmobile.

Religiously Dr. Parler served in many capacities at St. John's United Methodist. Among these were being a Sunday School teacher, serving on the Administrative Board, as well as being Chairman of the Board of Trustees.

Dr. Parler stayed very active with the hobbies in his life. Included in these are: fishing, bird hunting, raising and training his bird dogs, cattle farming, and forest management.

Dr. Parler married the former Ann Miller, and they had two children: John W. Parler, III and Robin Ann Parler Taylor.

Improve patient care and protect your practice as soon as you begin electronically prescribing. On January 1st, South Carolina law will require doctors to electronically prescribe any controlled substance included in Schedules II, III, IV, and V. e-Prescribing controlled substances is the first step toward maximizing your entire prescription process.

Consider transitioning every prescription away from traditional methods to electronic. When you do you'll experience a notable shift in your workflow. Electronic prescribing offers flexibility as well as key integrations and automations to help to remove human error, verify correct prescriptions and reduce the risk of misuse.



For example:

- Prescribe on Any Computer, Laptop, Tablet or Phone. Prescribing on any computer or device, gives you maximum flexibility to provide attentive care to your patients and create an efficient workflow for your practice
