Regretfully this activity stranded our Friday speaker Dr. Jeff Brucia, preventing his scheduled presentation. SC GKAS Donates Over \$250,000 In Care

The February 4th weekend was the beginning of South Carolina's ninth "Give Kids A Smile" donated dental care event. Although all numbers have not been submitted, it appears that SCDA volunteer dentists provided over \$250,000 of free dental care. This was possible with the collective efforts of assistants, hygienists, volunteers and a wide assortment of private and public facilities.

In 2008, GKAS evolved into a less centralized program. This year's volunteers have seen children that have already been radiographed, evaluated and cleaned. Midlands Technical College, Aiken Technical College, York Technical College, MUSC, Spartanburg Community College and Greenville Technical College provided numerous screening and restorative services. In many situations patients were referred to private dental offices from screening sites. The centralized pre-visit examination has been a great advantage in efficiency. Many dentists agreed to complete needed care for kids and teens that were referred from the Give Kids system. This is where the

numbers increased.

There are a few concerns that recently have helped and hindered the program. De-centralizing care has been a necessary change. However, fewer dentists participate when they realize that the children must be seen in the private office setting. Many elect to see the patients on an isolated Friday. Pediatric practices often will simply bring the children into their base schedule. More individual care is delivered, follow through is superior over the old design, but collection of records and data is complex. The usual supply line of distributing materials from ADA and dental companies is often interrupted due to the private office enrollment.

It is hopeful that in the future, GKAS can expand the SC base of dentists interested in this program. Look for more information in the late summer.

Prevention is the Intention

Look at this picture. That is me on the left, circa February 1976, talking with a child and her father about good dental care. This was part of the "National Children's Dental Health Month" program in which hundreds of us participated. Like many of my readers, you too may have donated time to offer a dental presence on behalf of good oral health. Of course the times have changed, yet we still use flip charts to talk with patients and parents. The process is important!

Besides the obvious reminder from Gene Atkinson with the photo, the important lesson is that dentists still educate. We give time and expertise to help our patients. Over the past few months, and as school ramps up after the summer break, we will again be called upon to do screenings, speak with groups or simply take time away from the office to interact. Share our story. Help families find a common voice for care. Hopefully find a dental home.

Prevention is the Intention! How can patients overcome dental disease? By fixing the disease? No, it occurs by controlling or curing the disease. How does that disease get eliminated? Education and the investment of quality time. Stand up for what we believe, invest in the community.

In some ways I see the landscape change. Screenings for GKAS show fewer gross decay and neglected kids than we saw nine years ago. A lot of this is due to the results of NCDHM and GKAS. Education and quality time. The process works.

SCDA is approaching our third DAD Day. Now I realize that adult care is a bit different from kid care. I also perceive that the intent of both programs is also different. But after emergency care is accomplished, and the patient has the opportunity to converse with the dentist, then the outcome is to educate. Cost may be the barrier, but health is the objective.

It is a story replayed frequently. I invite my fellow dentists to invest in this process. Get out of the "practice routine" and help SCDA improve dental health on a broad scale. Medicaid insurance changes will make the path more difficult, and make our need for prevention more necessary.

Go out and do good!

Insurance Filing for Dummies

Dear Phil,

I read your editorial in the last bulletin regarding the recommendations made by insurance companies on bridgework. I would like to try to clarify the response from the insurer's perspective. I practiced general dentistry for 23 years in SC before being diagnosed with an eye disease which shortened my clinical career. I have been working as

a dental consultant for the last 3 1/2 years.

All insurance companies have limitations and exclusions on replacement of teeth. For most companies, we have to look at the missing and unreplaced teeth in the arch, as well as those planned for extraction. With multiple missing teeth in an arch being restored, an alternate benefit for a partial denture will apply. What restorative dentists need to understand is that this is a benefit (payment) recommendation only, not a treatment recommendation. The insurer is not telling the dentist to do a partial denture. They are only applying a benefit to the patient based on the guidelines of his or her plan.

When an alternate benefit applies, we do review the abutment teeth to determine whether they need crowns on their own merit. We can recommend benefits for single crowns on those abutments that do require full coverage.

Unfortunately, dentists (as I did when practicing) and patients feel that the insurance company is dictating the treatment being performed. This is not the case. They are only applying a benefit based on the insured's plan.

Hopefully, this gives SCDA dentists a better understanding of the process, and in turn, they will be able to more effectively explain the insurance company response to their patient.

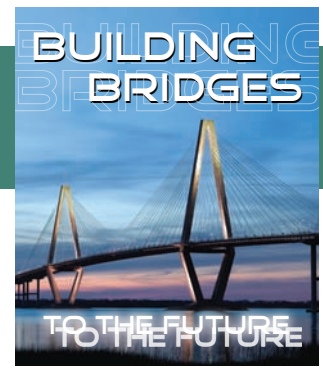

President's Message



Last June at our annual retreat for incoming SCDA leaders, we focused on a number of topics which the executive committee felt were of strategic importance to the future of our association and our profession. The round table dialogues held at this event yielded many fresh ideas and excellent new approaches on ways to solve some ongoing problems and improve many of our existing programs. In evaluating the feedback which we received as a result of these discussions, we noticed that the most frequently recurring theme was the need for a comprehensive orientation and organizational training program specifically geared to new incoming SCDA leaders; in essence, a basic Leadership 101 course. Our President-elect, Dr. Betsy Jabbour, was particularly enthusiastic about this concept and graciously agreed to develop a curriculum, arrange for instructors, act as director/host for the events and, with the assistance of staff member Mark Brown, organize the entire program. They have done an

outstanding job, and I wanted to present a progress report on what has been done so far and to let our members know where we are headed in the future.

Our first program was held on Friday, January 21, 2011, at the Columbia Conference Center. Dr. David Watson opened the meeting with a presentation on the organization and operation of SCDA. He talked about the relationship of the SCDA House of Delegates (setting policy) and the SCDA Board of Directors and Executive Board (carrying out policy) as well as the execution functions of various committees and task forces. Also, David covered the purpose and function of other SCDA divisions such as Member Benefits Group, SCDA Foundation, Disaster Relief and DenPAC Board, and he presented an overview of how these various boards, committees, task forces and divisions interact to carry out the business of our association.

Hal Fair followed David with a similar presentation on the organization and operation of the ADA. Hal talked about the 16th District of the ADA (composed of delegates from SC, NC and VA) and about the election of a trustee from the district to represent us on the ADA Board of Directors. He also covered the process of electing the ADA President and an overview of the role played by delegates/alternates to the ADA House of Delegates in creating resolutions which establish the basic policies on which the ADA operates. Finally, Hal concluded by stressing that staying well informed on both state and national issues is vitally important so that leaders can make good decisions on policies which affect the future of our profession.

Next, ADPAC chairman, Dr. Gary Oyster, talked about political advocacy and the critical role that it plays in effecting the legislation which regulates the dental profession. Gary strongly stressed the fact that PAC money is a key factor in gaining access so that our voice will be heard by our legislators. Our own legislative chairman, Dr. Jim Mercer, followed up by emphasizing the similar role that DenPAC plays on the state level in assisting our lobbyist and committee members in keeping our lawmakers informed and developing good working relationships with them. Dr. Jabbour concluded our first program with emphasis on the connections and inter-relationships of the ADA tripartite system (district/state/national) and on how organized dentistry works together to promote the best interests of our profession and the patients it serves.

Session number two was held at the SCDA office, on Friday, March 11, 2011, and we were most fortunate in having the new ADA Chief Legal Counsel, Mr. Craig Busey, who spoke to us about officer fiduciary responsibilities. During the discussion phase, questions arose about the recent problems that the North Carolina Dental Society has experienced with the FTC and Mr. Busey touched on ways to avoid entanglements with government bureaucracy. The discussion was lively and well received by those in attendance. The second half of the program was given by our own lobbyist, Mr. Richard Davis, who entertained the group with his usual "state house" humor, but in the process, he provided an excellent overview on how the legislative process really works. He pointed out that developing a high level of credibility and trust with our legislators is a crucial part of his job. When legislation comes up dealing with dental health care issues, we want them to look to him as the spokesperson for SCDA to provide accurate information and well reasoned advice. Finally, Richard concluded by pointing out that the contact dentist system is vital in providing that information and advice in a timely manner. Dr. Jabbour ended the second session by presenting a number of "cookie cutter" documents to assist district officer in carrying out their responsibilities and getting their district well organized. These documents are available on the SCDA website in the district sections under the About Us tab. Again, those in attendance felt that they received valuable knowledge that will be useful to them as new officers of the association.

Where do we go from here? Originally we had planned to hold three sessions with the third scheduled for 8/19/11. In talking with Dr. Jabbour, we decided that due to several factors (proximity to the DAD event 8/25-27 and the additional cost per program) it would make sense to have the third session as part of the BOD retreat in June. In future years we hope to create a more streamlined version of this course which could start at the annual retreat and then involve one additional meeting (possibly as part of or on the same day as another board meeting). No final decision has been made at this time, however, the leadership orientation program has been well received and will certainly become an integral part of the SCDA schedule of the future. Again, I would like to say a special "THANK YOU" to Betsy and Mark for all the time and effort which they expended in putting this program together. Kudos to both of you!

I would like to thank the auxiliary groups who join the SCDA each year to help make the Convention a success - Lori Paschall and Lois Bell from the Assistants group and Tom Hughes from the Dental Lab Association. All of these individuals play an important role helping make the convention a success year after year. I would be remiss if I did not say a special thank you to Laura Jordan who makes sure all the necessary details are covered for the Convention.

New BlueCross Pre-authorization Guidelines

If you are on the group medical plan offered through the SCDA, then by now you should have received a mailer from BlueCross / BlueShield of South Carolina (BCBSSC) referencing new pre-authorization guidelines for certain radiology and imaging services.

As I mentioned in my e-gram last month, BCBSSC began a radiology and imaging program effective April 1, 2009, that reduces unnecessary or duplicate radiology and imaging tests. The program requires pre-authorization for services such as magnetic resonance imaging (MRI), magnetic resonance angiogram (MRA), computed tomography (CT) and positron emission tomography (PET) scans.

The use of outpatient imaging is rapidly increasing and imaging costs continue to grow each year. BCBSSC is working with National Imaging Associates (NIA) to meet these challenges. The program includes a pre-authorization process which promotes the use of appropriate services.

As previously stated, BCBSSC began this program in April of 2009 in order to give you and your doctors enough time to familiarize yourselves with the new requirements. Previously, they did not reduce benefits for you if your doctor didn't get pre-authorization in advance.

Effective May 1, 2011, BCBSSC will begin to enforce the radiology and imaging program penalties. They now require pre-authorization for certain radiology and imaging services, including MRIs, MRAs, CT and PET scans. They will require it for all doctors, regardless of the provider state location or network status.

The Pre-authorization Process - Pre-authorization is required for all outpatient imaging services in any setting (out patient facility, imaging center, physician's office, etc.) BCBSSC does not require it in an emergency room or inpatient setting. The provider must get the pre-authorization through NIA before rendering the service. If pre-authorization is not obtained prior to service, BCBSSC will not reimburse the provider and the provider may bill the member.

Members are responsible for ensuring these pre-authorization requirements are met or they will be liable for the charges incurred except when they are seeking the services of a participating provider in the state of South Carolina. If you use ANY provider outside South Carolina or ANY out-of-network provider, you are responsible for making sure the provider obtains prior authorization.

- The provider must request the authorization from NIA.
- Members can check the authorization status by logging into My Health Toolkit.

To ensure pre-authorization, simply show your ID card to your provider and ask the provider to follow the pre-authorization instructions on the back of the card. They also recommend that you confirm the pre-authorization is on file prior to you receiving the service.

Nominations Needed for the 4th Annual Carlos Salinas Award

TO RECOGNIZE A SOUTH CAROLINA DENTIST SERVING PATIENTS WITH SPECIAL HEALTH CARE NEEDS

The South Carolina Dental Association (SCDA) and the South Carolina Oral Health Coalition (SCOHACC) have established an award to honor a dentist for excellence in providing care to and advocacy for individuals with special health care needs. This is the fourth year of the award, co-sponsored by Specialized Care Company, and nominations are now being accepted.
