DAD A WOW Event!

The SCDA and hundreds of volunteers hit a home run with the very successful Dental Access Day (DAD) event in Charleston. The first of South Carolina's blitz adult care programs was held on August 27-29 at the North Charleston Convention Center. The results for this effort speak volumes for the dedication, focus and commitment of those involved.

The DAD project was initiated more than a year ago as the SCDA Board and House previewed the efforts for adult dental care in North Carolina. That state had successfully held a number of events and collected hardware and supplies that allowed them to set up a site overnight. And so to that model, and with the assistance of NC as well as Virginia, SCDA elected to hold its own DAD event. Logistically it is a major effort and requires the obligation of a local community host organizer. Our host in Charleston was the SeaCoast Church.

Thursday morning a caravan of big trucks pulled in to the convention center's parking lot. From outward appearances there was a rock concert arriving, but the big show was really the first wave of equipment. The skilled crew and volunteers unloaded and assembled the portable treatment centers skillfully and by 1 PM the preliminary clinic was tested. A group of patients from the clinic maintained by SeaCoast Church were the first to receive screenings and care. Their role was also to assure that all systems were functioning properly.

That evening after the preliminary clinic was completed, a BBQ buffet catered by Sticky Fingers was held for the volunteers that were present. It was a celebration of the pending event. The next morning 6 AM, gathering showed that patients were lined up already for free care. Since the clinic was a "first come" basis, there were people there that had come in before sunrise to have a place in line. Once the early triage identified the patient's needs, the big clinic came to life. There were approximately 350 to 450 volunteers on site. Dentists and dental students numbered over half of the clinic. One would have to participate to understand the many systems that were in place to support the field clinic. All sorts of adult dentistry were offered including prophies, restorative work and simple surgery.

Friday's clinic was over at 5 PM and there were



patients that were scheduled to return on Saturday. The next morning began the same as the previous day. Long lines and early morning patient evaluations were the norm. There was a general sense of enthusiasm as the day unfolded. Patients expressed great appreciation and the volunteers felt uplifted by the service. Needless to say, a lot of dentistry was done. It is estimated that 1458 patients were cared for during the first SCDA Dental Access Day event for a total of more than \$600,000 worth of donated care. Many community and state leaders, press and interested citizens visited the site. It was a huge success!

Plans are already underway for the development of future DAD projects.

ADA to Celebrate 150th Anniversary in Honolulu

The American Dental Association (ADA) will celebrate its 150th birthday celebration during the 2009 ADA Annual Session and World Marketplace Exhibition, to be held in Honolulu's Hawaii Convention Center from Sept. 30 through Oct. 4. Approximately 24,000 total attendees are expected to come together in Hawaii for this milestone event, including more than 7,000 dentists.

"This year's Annual Session is shaping up to be a fantastic event," said Dr. Robert L. Skinner, 2009 chair, Council on ADA Sessions. "Although we are faced with a very difficult economy, we are very excited to welcome so many attendees to one of the best destinations in the world to celebrate our 150th Anniversary."

Attendees can choose from among more than 180 continuing education courses over four days—and the majority of CE seats are free with registration. CE courses will run earlier in the day than usual, from approximately 7:30 a.m. to 2:30 p.m., to compensate for the time change from the U.S. mainland to Hawaii. The World Marketplace Exhibition will be open from 7:30 a.m. to 3:30 p.m. Thursday, Oct. 1 through Saturday, Oct. 3.

The ADA will celebrate its sesquicentennial with two spectacular events: the Opening General Session and Distinguished Speaker Series featuring Sidney Poitier on Wednesday evening Sept. 30; and "An Evening Under the Stars" featuring Polynesian culture and performances on Friday, Oct. 2. Both events will be held at the famous Waikiki Shell outdoor venue.



ADA and ADEA Launch Groundbreaking Education Project

New for 2009, the ADA and the American Dental Education Association (ADEA) will launch a groundbreaking educational opportunity in which dental students and faculty can gain remote access to select live-patient continuing education courses being held at the 2009, 2010 and 2011 ADA Annual Sessions. This program is generously sponsored by Henry Schein Dental.

Through this new initiative, North American pre-doctoral and post-doctoral dental students and faculty will have password-protected access to six live-patient courses each year in the ADA's industry exclusive Education in the Round (EIR) learning format. Federal Subsidy for Continuation of Coverage

About a month or two ago, your practice should have received a continuation subsidy packet describing what your practice needs to do for any employee who was involuntarily terminated and would like to continue their medical insurance coverage for a period of 6 months. This packet and article applies to practices with less than 20 employees.

The purpose of this government subsidy is to reduce the employee's insurance premium to 35%. The remaining 65% of the premium will be subsidized by BlueCross/BlueShield of South Carolina (BCBSSC). Click [here](#) to retrieve this information from the SCDA website. Every office covered under the group medical plan must sign and return the "Addendum" (one pager) that is included in this packet regardless if you presently have an ex-employee that qualifies for this subsidy.

The remainder of this paper work needs to be completed if you have an employee who was let go and would like to continue their coverage for a maximum of 6 months. This subsidy does not apply to anyone who leaves the practice on their own grounds or who was let go due to gross misconduct.

If your practice has an employee who qualifies for this subsidy, they will need to complete the "Request For Treatment As An Assistance Eligible Individual" forms which consist of 3 pages and you, the employer, will need to complete the one pager titled "State Continuation Premium Assistance." Once this paperwork has been completed, fax to Rebecca Finley at (803) 264-5374 or mail to her attention at Rebecca Finley, AX-D10, I-20 @ Alpine Road, Columbia, SC, 29219. This paperwork will provide the proof BCBSSC needs to establish the subsidy which would be reflected on your future billings with a reduced premium of 35% for affected employees.

The one page medical change form requesting state continuation still needs to come to my attention at the SCDA office at (803) 750-1644.

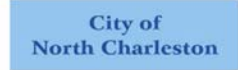

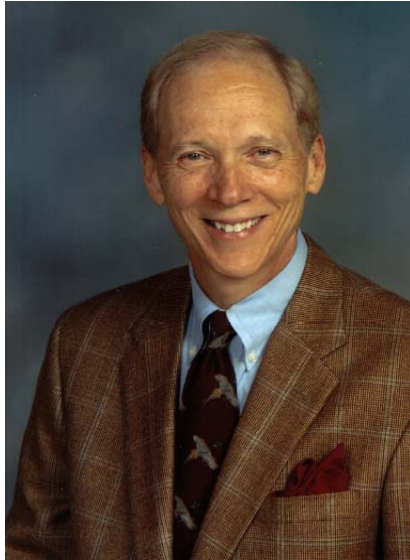

President's Message



Much discussion these days concerns mercury contamination. Just last week a new study released found nearly all fish harvested and tested in the United States contained some traces of mercury. As a matter of fact, the second highest mercury concentration of any fish tested was caught in the Edisto River in South Carolina. While most of this mercury contamination is traced to worldwide use of coal-fired power plants and other industrial polluters, dentistry should do all it can to limit mercury contamination.

As of 2005 amalgam use in the United States had declined to one third of the 1979 level (52.5 million amalgam restorations compared to 157 million amalgam restorations in 1979). Most dental offices currently use some type of basic filtration system to reduce the amount of mercury solids passing into the waste water. In 2007 the American Dental Association updated its voluntary best management practices to include the purchase and proper use of an amalgam separator. This will increase the recycling of amalgam waste and thus reduce mercury contamination.

The Environmental Protection Agency, states, and localities have implemented mandatory and voluntary programs to reduce dental mercury discharges into publically owned water treatment works. Specifically, 11 states and 19 localities have mandatory requirements for dental amalgam separators. At least 20 other localities have voluntary programs to reduce dental mercury discharge into wastewater. Your SC Dental Association has a new task force headed by Dr. Todd Blevins of Mullins. This task force is to study the dental mercury discharge issue and report back to the Board of Governors its findings and recommendations. An amalgam separator may be in your future. These units are relatively inexpensive to purchase and install. Maintenance is very minimal. This small investment by all our member dentists will send a loud message to the Environmental Protection Agency and our state government that we do care about our environment.

But, our efforts to limit amalgam discharge and mercury contamination do not stop there. All scrap amalgam, to include non-contact scrap, patient-contact scrap, used amalgam capsules, chair side trap scrap, and vacuum pump filter scrap, needs to be placed in properly labeled wide mouth jars and sealed. When full, this scrap should be sent to a certified recycler. To my knowledge, many practitioners are simply throwing waste amalgam into the trash. Many municipalities incinerate garbage and thus release the mercury vapor into the air.

There will be much more on this topic in the months to come. Let's not wait for another report to start cleaning up our act. We are a profession that is committed to caring – caring about our patients and our environment.
