SCDA Leads The Way in Membership Trend

After careful consideration of national trends in market share, your SCDA leadership decided that 2014 was a year to concentrate on modernizing the way in which a dentist is brought into membership of the Association. It was determined that the proper way to accomplish this change was to approach the component level to set the groundwork for change. I am pleased to report that each of the four districts have instituted changes in their by-laws that greatly streamline the process by which a dentist attains membership. Our district presidents and other officers are to be commended on their leadership in bringing about change that removes barriers to membership. When a new member joins the tripartite membership, it will now be the responsibility of the district membership committees to make sure that the member is welcomed into organized dentistry. Indeed, their first opportunity to attend a district meeting should now be a celebration of inclusion.

Membership in the SCDA is now showing positive momentum. Our SCDA membership manager, Maie Brunson, reports that South Carolina's total membership has reached 1998 for a market share of about 80.3%. While the latest statistics are not complete, you can be assured that our state will be near the top of the nation in member percentage. Serving almost 2000 members takes a great deal of work and I thank Maie, Sue, Deanna, Mark, and, of course, Phil for their efforts in our behalf.

The rest of the country is seeing the need to streamline the membership process similar to the way we have in South Carolina. Indeed, there has been a resolution proposed to the ADA House of Delegates that mirrors our action. Resolution 19 encourages each state/constituent to review their membership process and "that they support a consistent application process that minimizes membership barriers and presents a positive member experience." Again, thank you to our districts for putting us ahead of almost all other states.

However, our effort to streamline the membership process in South Carolina has yet another step to bring it to completion. At the SCDA House of Delegates meeting in December, there will be consideration of a by-laws change that will synchronize the component and constituent protocols for attaining membership in the digital age. I encourage every delegate, alternate delegate, and interested member to be present. This year's HOD on December 5 is being moved to the Doubletree Hotel in Columbia, SC to better accommodate the gathering. Please make every effort to attend this important meeting.

In closing, the big picture of the dental profession is changing rapidly. Corporate dental models, student indebtedness, workforce pressures, and other issues are making the future landscape of dentistry seem less certain than it did in the past generation. It is essential that a broad-based and engaged association of member dentists be ready to step forward to shape the future landscape.

Botox and Other Injectables

State Board of Dentistry Policy

In accordance with Section 1-23-40 of the 1976 Code of Laws of South Carolina, as amended, notice is hereby given that the State Board of Dentistry has adopted the following statement as guidance for dentists in the practice of dentistry under the South Carolina Dental Practice Act, Regulations and the Principles of Ethics as adopted by the Board.

Because treatments by injection involve the destruction of human tissue, and because the proper use of injection devices requires specialized training, this procedure may be performed by a dentist properly licensed in South Carolina subject to certain restrictions. The injection of Botox and other injectables should only be performed by a dentist licensed in South Carolina in accordance with the following criteria:

1. The informed consent of the patient must be obtained and documented and a record of treatment in accordance with the Dental Practice Act must be created.
2. A bona fide dentist-patient relationship must be established.
3. The procedure should be performed only in an appropriate clinical setting that ensures resuscitative capabilities and sterility.
4. The dentist must remain on-site and be immediately available for any problems that may occur. The dentist must perform and otherwise direct the course of the patient's treatment.
5. Procedures of this nature are limited to the perioral area.
6. The licensee must provide documentation acceptable to the Board as to the licensee's training, education, credentials and qualifications before undertaking to perform procedures of this nature.
7. Procedures of this nature must be for a dental purpose.
8. Procedures of this nature may be performed by a licensed general dentist
9. Procedures of this nature are defined as being limited to the injection of resorbable materials only.
10. Licensees performing procedures of this nature are subject to all provisions of the Dental Practice Act, Regulations and policies of the Board.

Protection of the public and the safety of the patient is the responsibility of the dentist. Patient protection is paramount. Although a dentist who conducts himself/herself in accordance with this policy may avoid disciplinary action by the Board of Dentistry, he or she may still face civil liability under some circumstances, and should therefore consult private counsel where doubt exists as to what actions are appropriate.

Can An Employer Fire an Employee Who Calls the Owner an “A**H*ole” on Facebook? Can It Fire Another Employee Who Simply “Likes” A Disparaging Post About the Employer?

Apparently not, according to a recent opinion by the National Labor Relations Board (“NLRB” or the “Board”).

A former employee of a sports bar discovered that she owed more in state income taxes than she expected. She posted a Facebook post saying:

“Maybe someone should do the owners of Triple Play a favor and buy it from them. They can’t even do the tax paperwork correctly!!! Now I OWE money...!!!!”

A current employee, Jillian Sanzone, posted her own comment: “I owe too. Such an a**....”

One other employee, Vincent Spinella, did not post a comment, but “liked” the former employee’s original post.

The sports bar fired both Sanzone and Spinella.

The NLRB found that the sports bar violated the National Labor Relations Act in terminating the employees because the employees were engaging in protected concerted activity by expressing concerns about the terms and conditions of their employment – activity protected by the Act.

The Board also found that the employer’s social media policy violated the Act in that employees would reasonably construe the policy to prohibit protected Facebook posts such as the ones posted by Sanzone and Spinella.

This opinion illustrates the ever-expanding view the NLRB has taken with regard to employee rights and protected activity with respect to employees’ use of social media.

Employers should review their social media policies to ensure they comply with federal law and recent NLRB decisions; and closely analyze actions they take with regard to employees who utilize social media to discuss their experiences with and opinions about their employer.

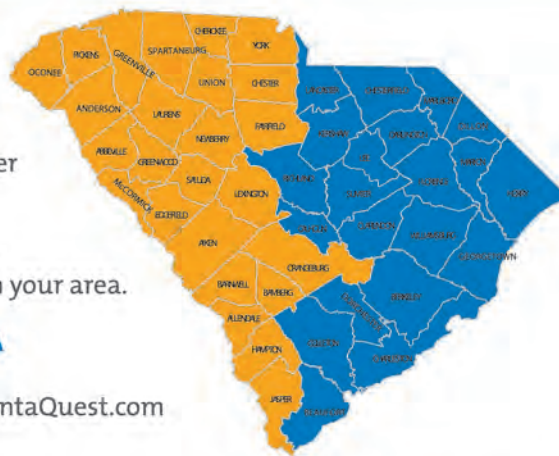

Executive Director's Notes

Often, the SCDA receives questions asking what the ADA and SCDA are doing for its members. While attending the recent ADA meeting in San Antonio, two items were highlighted that reflect how the ADA along with the SCDA is always looking out for the member and keeping them informed.

CIGNA Insurance

CIGNA is planning to roll out a dentist rating system on their provider website based on "cost effectiveness." ADA reviewed their methodology this summer, under a confidentiality agreement with Cigna and found it to lack appropriate scientific basis and responded as such to Cigna. It is based on cost and utilization patterns alone and the ADA felt it would be misleading to the public and potentially damaging to dentists.

Since then, the ADA has developed communications materials that were sent to the states.

There are procedural barriers for the ADA to respond immediately from a legal standpoint, but ADA Legal Affairs has already contacted outside legal counsel to assist in the determination of a course of action. Collaborations between the Council on Dental Benefits Practice, Government Affairs and Legal is developing a multi-faceted plan to deal with this development, which may include state legislative advocacy (insurance plans are regulated at the state level) and will certainly include development of additional information to members and state societies. The ADA will be monitoring the progress of that and assisting where they can.

The ADA is also developing an ADA News story to inform the membership. They are developing an "Appeal Your Rating" guide. An important point to stress is that members should appeal the rating based on faulty methodology, not the specific rating they receive, because the point is that there is a flawed rating regardless of whether the dentist receives a high or low rating. The ADA plans to have this produced in the coming weeks.

Ebola

In light of the first confirmed Ebola case diagnosed in the U.S., the ADA is reaching out to members with important information from the ADA and the Centers for Disease Control and Prevention (CDC). Even a single case of Ebola diagnosed in the United States raises concerns. As healthcare professionals, we must remain informed and vigilant on behalf of our patients, our dental team members and the public at large.

Information and resources on Ebola are posted on the CDC's website at cdc.gov. A checklist for healthcare providers specific to Ebola is also included on the site.

The ADA has long recommended that all practicing dentists, dental team members and dental laboratories use standard precautions as described in the Centers for Disease Control and Preventions (CDC) Guidelines for Infection Control in Dental Health Care-Settings.

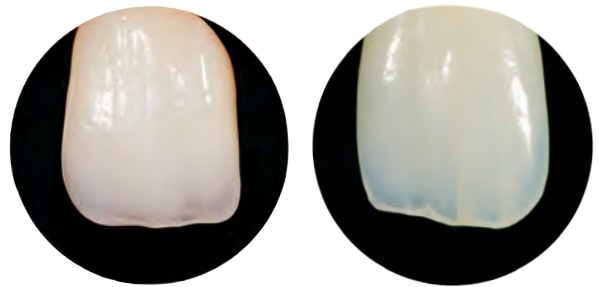
